With reference to the subject cited above, I furnish here with the detailed notification inviting applications from eligible candidates of CCIC/Craft/Other Technical Courses New Scheme (CC-20) for Regular and Supplementary examination for the courses mentioned in the Annexure-I, the revised Question Paper Blue print (CC-20 Scheme) is made available in Annexure-II, examination centers mentioned in Annexure- III and Time Tables are shown in Annexure-IV.

In this regard, it is informed that the regular candidates who intend to appear for the examinations can approach the Colleges/Institutes where they are studying (or) visit **www.sbtet.telangana.gov.in** for making fee payment online. After downloading the Hall Ticket from **www.sbtet.telangana.gov.in** the candidate has to obtain the signature of the concerned Head of Section/Principal before appearing for the examination. Further, Principals are requested to give the necessary instructions to the Head of Sections to sign on the hall tickets for subjects after thorough verification of eligibility.

The Principals of the concerned Colleges/Institutions where Regular examinations are being conducted are requested to ensure that the syllabus should be completed on or before examinations.

GENERAL INSTRUCTIONS:

- a) Practical Examinations of the respective courses shall be conducted after completion of Theory Examinations and the name and designation of the Examiner drafted from the Government Polytechnic for the said courses, shall be intimated to this office well in advance.
- b) Sessional/Practical marks of the candidates of the respective institutions shall be uploaded in the prescribed proforma placed in the SBTET website within a week after completion of the theory examinations and downloaded copies of the same duly attested by the Principal concerned with institute seal, shall be sent to the Board within the stipulated period as mentioned in the notification.
- c) The CCIC Institutions should bear the expenditure towards practical examinations and remuneration to the Observers and External Examiners should be paid as per norms only.
- d) The SBTET will not bear any expenditure in connection with practical examinations. No Expenditure towards practical examinations is allowed in D.C. Bills as the courses are being run by the self-financing Institutions.
- e) Once amount is deducted, after submitting the application, no amount will be refunded.
- f) Theory Examinations will be conducted in the month of August-2026 as per the Examination Time.
- g) Hall Tickets can be downloaded from the portal www.sbtet.telangana.gov.in. Once Hall Ticket is generated, no correction will be made.
- h) The candidates (Regular/Supplementary) have to file their online applications.
- i) The candidate has to select whether he is a regular or backlog (appeared but failed in the previous attempts only).
- j) The backlog candidate has to select **Backlog** and enter the PIN, it will display the candidate details and the backlog subjects. Click on submit and pay the fee through Online.
- k) The regular candidate has to select the option **Regular** and enter details of the application and communication details.
- l) The photos uploaded by the candidates will be used on the hall tickets and the same will also be used on the award certificates of passed candidates. Owing to this, the candidates are requested not to upload the Black & White photos and photos taken with wearing cap/cooling glass and the photos with odd backgrounds defeat the purpose of clear identification.
- m) The Principals of (a) TG. Vikalangula Co-op. Training Cum Production Centre for Physically Handicapped, Hyderabad (b) N.V.Reddy Viswas Trust, Hyderabad (c) Ramananda Centre for Advanced Learning and Research for

Visually impaired, Secunderabad (d) Aliyavar Jung National Institute for Hearing Handicapped, Secunderabad and (f) National Institution for visually handicapped, Secunderabad, are informed to upload the names of the eligible blind candidates along with photos of the candidate from their respective institutions without fee.

NOTE: The above institutions mentioned in the section (m) are requested to arrange scribes for their students as per norms and as per requirement.
